Growing up in Mary Tavy - Part Two

An account of Mary Tavy by Annette van Oppen who was born in 1936 and spent her childhood in Tavy House. Annette had been a journalist with the Tavistock Times and later a teacher and was married to Richard van Oppen, Coroner and a Mayor of Plymouth City. She died in 2011.

Her story is being serialised over several issues; the first part was published in the Newsletter in issue 18, earlier this year.

There were several retired army officers living in Mary Tavy during the war (my Dad was one of them) and they were all very keen to

create a Home Guard which would be the envy of the world! Colonel Thompson of Blackdown House [Blackdown Nursing Home] was the commanding officer (I believe he was actually a retired bank manager but given the rank of Colonel for the duration of the War) and he soon had plenty of volunteers. My Dad was the supplies officer and he managed to get the platoon everything they needed.

All sorts of exercises were organised which involved them marching around Mary Tavy and bossing us all about but sometimes they had to rehearse capturing Germans and the WVS were the unlucky victims of this one! On one occasion when this was taking place several of them came running through our garden in gentle but determined pursuit of some unfortunate lady when one of our Scotties dashed out and fastened its teeth on the leg of one of them. Try as he would, the embarrassed soldier could not shake off the feisty little dog and had to run past our windows with the dog attached. Dougie let go at the gate, however. The WVS were duly rounded up and imprisoned in their hut and forced to provide the victorious army with refreshment, which they did ... later announcing that they had poisoned the tea and so the men were all dead and victory was theirs! Colonel Thompson was not amused but everyone else was!

The meetings of the Home Guard often took place at Blackdown House where Colonel Thompson had a wonderful air raid shelter under the rockery. I can just remember seeing down there once but I think it was when my brother and I were exploring and we were not supposed to know about it so we were sworn to secrecy (or rather threatened with dire consequences if we told anyone). It may still be there and it would be fun to uncover it. The other thing I remember about Colonel Thompson is that he believed that children should be seen and not heard but his wife was very kind; she once

gave us scones with real butter and strawberry jam for tea! Later on I was allowed to use their drive and garden as a short cut to the moor as my pony's field was across the road from their gate and it saved me from having to ride on the main road, which became quite busy after petrol rationing was lifted and also quite dangerous as traffic speed increased tremendously.

A memorable incident which involved the Home Guard and us concerned something that my brother and I found when we were out on our bikes one late summer day. As we pushed up the hill from the station we decided to go into a field to look for blackberries. As soon as we climbed over the gate we saw it – this huge, white billowing mass of silk! It was a parachute! We dashed home and ran into the house shouting to Mum that we had found a German! She listened to our garbled tale, took it seriously, told us to stay indoors and got on the phone to Colonel Thompson (in those days you went through a person on a switchboard and it took some time if the lines were busy).

Not only the Home Guard but the whole male population of the village of Mary Tavy turned out with whatever they could lay their hands on to put fear and trembling into the enemy! Women and children were to stay at home!! The brave men surrounded the field and gradually closed in; they approached the billowing canopy with cautious determination. The nearer they got, the slower they went until, finally they were there! They looked around for the enemy, dead or alive! He was nowhere to be seen. Must they organise another search party? Could he be armed? Colonel Thompson had to think fast!

Then someone looked a bit closer at the parachute. It was not a parachute. It was a barrage balloon which had broken loose from its moorings in Plymouth. Their function was to confuse and disrupt enemy aircraft and they certainly succeeded in that – but occasionally they broke loose and then it was the population who were confused and disrupted! The village ladies burst forth with scissors and within a very short time there was absolutely nothing of it to be seen!

Cemetery concerns

Some of our readers will have seen the articles in the Tavistock Times in mid-September, or might have read the minutes of Council meetings, and will know there are people who feel they are faced with difficulties in dealing with the Parish Council on matters concerning the cemetery. The problems relate to wording wanted on a gravestone, and flowers moved from graves.

As well as representations made to the Parish Council in letters, phone calls, and at a Council meeting, a petition was set up to galvanise views from others who feel the rules and the attitude of the Parish Council are inappropriate and uncaring. The Parish Council has rules in place which they believe are appropriate and which all those who have bought plots have agreed to. Those who have contacted the Parish Council have had personal responses to that effect. The Parish Council had 'no comment' to make regarding the articles in the Tavistock Times, but their view is given in the Parish Council feature on page 4 of this Newsletter.

Our parish bounds have been beaten

On a not-too-hot and not-too-wet Saturday in August around two dozen intrepid Mary Tavy residents, and a couple of dogs, set off to perform the traditional act of Beating the Bounds. From Tavy St Mary Church they were sent off with aptly chosen prayers spoken by lay preacher Hazel Butland. Thankfully good weather stayed with them for the duration and an enjoyable day was had by all. Twenty five walkers in total met the challenge of walking part or all of the boundary of our village. The range of age and ability spanned the generations with the youngest walker being just six years old whilst the eldest were into their seventies. The day was rounded off with a social gathering of walkers and volunteers enjoying a well earnt barbeque on the Recreation Ground. Thanks and congratulations go to all those who took part and to those who helped organise the event. It would not have been such a success without them.





Mary Tavy Parish Council

We are delighted to report that the very successful Beating of the Bounds was completed on 12th August and that Planning Consent has recently been received for the construction of the DAA night landing site on the Recreation Ground. We are also pleased to report that we have commented to the DNPA regarding the Parish Settlement Profile they published as part of the Local Plan review. The terms of the new Local Plan will of course affect everyday life in all Dartmoor communities. Interestingly, immediately prior to the closing date for such comment only 8 parishes out of over 50 had made such a return to the DNPA!

A very small minority of local people seem surprised that regulations are in place for the proper operation of our parish cemetery. Regulations have been in place for the last 15 years and have remained largely unchanged despite the annual review process. The regulations are not arbitrary and are based on best practice drawn from the regulations of the Diocese of Exeter and neighbouring Burial Authorities, such as Tavistock Town Council, and guite frankly plain common sense. The 15 regulations are simple and straightforward. They provide a balance between the needs of the bereaved and our duty as a Burial Authority to ensure that our cemetery offers a safe, tidy, respectful and dignified environment for all. The parish cemetery is council property and control of it and its operation is totally in the hands of MTPC. Councillors expect that all those who purchase an Exclusive Right of Burial or the Right to erect a headstone with an inscription will comply with the cemetery regulations. The same level of compliance is required of all visitors attending graves in the parish cemetery where the regulations are on display.

While all parishioners have the right to elect to be buried in the parish cemetery, our agreement is dependent on the purchaser accepting the regulations in force at the time and any subsequent amendments made to them. All those who purchase any of the Rights relating to a burial are given a copy of the Charges and Regulations booklet. It has always been the policy of MTPC to view this booklet as, in effect, being the Terms and Conditions governing any sale of Rights. As several weeks elapse between the occurrence of a death and the interment we are reassured to note that

bereaved families are able to cope with this legal aspect of a burial. As our Clerk is readily available to give advice and clarification prior to an interment those who still find our rules unacceptable should seek to use an alternative burial ground. They will of course discover that alternative venues have much the same rules as we do.

The parish cemetery is financially supported by Parish Precept funds. Therefore the cost of maintenance is important and is why we have asked those who insist on laying floral tributes along the length of a grave to follow cemetery regulations. These ill-considered actions make it more time-consuming for our contractor to cut and strim the grass. In simple terms, the longer it takes, the more it costs. As MTPC has an enviable record over the last 2 years of reducing the Parish Precept we feel certain that parishioners will wish to support us in keeping a tight grip on our expenditure of their money. Your Council remains unmoved by the actions of individuals who, simply because they cannot have their own way, resort to parading their discontent in local newspapers and social media. Equally we view petitions drawn up and signed by non-residents to have little value as such people do not contribute towards the management costs of our cemetery. We of course encourage all parishioners who feel they have a justifiable complaint to bring it to our attention in Parishioners' Time prior to our monthly Parish Council meeting. It remains our firm belief that good management and insistence on regulatory compliance is the only certain way of ensuring that people will use the cemetery respectfully and with due regard for the sensibilities of other parishioners.

Much to the wry amusement of Councillors, but also tinged with a degree of sadness and despair, our Clerk has informed us that a parishioner who was complaining to her about a Council decision firmly believed that we are paid for the work that we undertake on behalf of the community. The reality is of course quite the opposite. Parish Councillors receive no payment at all for holding public office and seldom even claim expenses incurred in the execution of their duties. The situation is totally different for the next 2 tiers of local government where allowances and expenses are much more the order of the day. Is this perhaps the reason why we still have 3 vacancies on MTPC?



We look forward to seeing you there.



Dartmoor announce potential development sites

We announced in an issue of the Newsletter last year that Dartmoor National Park was issuing a 'call for sites' as part of their Land Availability Assessment (LAA). The process identifies sites with potential for housing, employment and traveller uses, assess their suitability and consider when they are likely to be developed.

The LAA is not a policy making document, it does not decide where new development will take place. Decisions included in this report do not mean planning permission has or will be granted for a site. They are not a planning decision made by DNPA, sites deemed acceptable by the panel are simply technically feasible. All sites will still be required to go through the normal process of planning permission process and are not guaranteed permission.

The 2017 LAA Report has now been completed and can be viewed on the DNPA website.

Five sites in Mary Tavy are included in the 2017 LAA Report. Three of those were listed in the previous Report, of which two were found not to be suitable for development. The site which remains listed as suitable is —

Land to the east of Brentor Road: Listed in 2014, suitable for max. 26 homes.

Two new sites were submitted for consideration in 2017. They are –

Land adjacent to Sunnycote: Not considered to be suitable for development.

The Stannary and Croftner: Suitable for c.14 homes, existing buildings to be retained.

Better mobile phone coverage for many in Mary Tavy

The whole of the Mary Tavy area will soon have vastly improved O2 and Vodafone mobile phone coverage. Currently the coverage is classified as outdoors only, and doesn't include outlying areas. The change is due to a new mast erected in Horndon by Telefonica.

Telefonica's representatives looked at 10 possible sites in and around the parish. Some were not suitable because of tree heights or lack of space, some landowners did not want a mast on their property. Land at Lower Creason was found to be suitable in all respects.

Consultation letters were sent last October to the Borough Councillor, the Parish Council, the School and the School Governors. This was followed up by a planning application which was granted in June 2017 by DNPA Planning under the powers of 'permitted development'. Erection of the mast started in August, but it can take between 6 months to a year for the service to go live.

Users of O2 and Vodafone will not only find huge improvements in the coverage for mobile phone use, but also 2G, 3G and 4G.

Some concern has been expressed that mobile phone equipment can be a hazard to health, and the mast is situated quite close to the school. However O2 has told us that "radio base stations operate at low power and emit low levels of radiofrequency fields, typically hundreds or thousands of times lower than the guidelines."

If anyone would like further details the Jubilee Group holds copies of documents which were submitted by Telefonica with their planning application.
